



KARMALOO KAZBAH DETAILS

Karmaloop Kazbah is a new feature developed by Karmaloop.com, where a few select vendors can showcase and sell their original art, design and products. For a monthly fee and a percentage commission of all sale transactions, Kamaloop.com will host the selected Vendor's Kazbah storefront.

BENEFITS TO KAZBAH VENDORS:

Karmaloop will provide Vendors with:

- Access to Karmaloop.com's audience of 1 million monthly unique visitors;
- A world-wide, non-exclusive, license to use the Karmaloop Kazbah in connection with the sale of the Kazbah Vendor's original product;
- A world-wide, non-exclusive, license to use the proprietary functionality (that is, the technology) of Karmaloop.com;

KARMALOO ADMINISTRATION SERVICES:

- Running and operating the functionality of the Karmaloop Kazbah, including all related technical maintenance; and
- Ordering and payment processing for products sold on the Karmaloop Kazbah.
 - Upon each sale, Karmaloop electronically will forward an invoice/receipt of such purchase to the customer and the Vendor whose product is purchased. The Vendor will then be responsible for shipping the product in accordance with the Vendor's established shipping policy.
 - On a monthly basis, Karmaloop will send the Vendor a check equal to 65% of the sales of the products sold through the Karmaloop Kazbah (see Karmaloop monthly commission information below).

KAZBAH VENDOR RESPONSIBILITIES:

- Keep up the good work with your dope products!
- The Vendor will be responsible for updating his/her Karmaloop Kazbah page on a regular basis and keeping the page nice and fresh; and
- The Vendor will be responsible for implementing and will post information about the following policies/processes:
 - Shipping

- Returns and/or exchanges
- Customer service (except for questions related to technical processes, Karmalooop will not be responsible for customer service for the Karmalooop Kazbah)

COMPENSATION TO KARMALOOOP.COM:

In exchange for the right to showcase and sell their product on the Karmalooop Kazbah, Vendors will pay Karmalooop the following fees:

- A monthly "stall rental" fee of \$30.00; and
- A commission fee equal to 35% of the sales of the Vendor's goods.

SETTING UP:

The Vendor will provide Karmalooop with the following items:

- Digital photos of the Vendor's products to be displayed and offered for sale on the Karmalooop Kazbah, including item/product descriptions, names and other relevant information.
- Information related to the Vendor's shipping and return policies (which will be determined by the Vendor in conjunction with Karmalooop) and the Vendor's direct contact information (for customers to be able to contact the Vendor about his/her products).
- Any other information the Vendor wants to post on the Karmalooop Kazbah, except that the Vendor will not be allowed to post any language or products that are deemed by Karmalooop, in its sole discretion, to be racist, sexist, homophobic or otherwise offensive and insulting (Karmalooop will have the right to remove at any language or products that it deems, in its sole discretion, to be racist; sexist, homophobic or otherwise offensive and insulting at any time).
- Once Karmalooop reviews and consents (in its sole discretion) to the above information, Karmalooop and the Vendor will enter into a License Agreement and will set up shop!

DURATION:

The first term of the agreement between Karmalooop and the Vendor will last for 6 months (this is called the Initial Term) and will be renewed automatically for additional periods of 4 months each, unless either party ends the agreement according to procedures set out in the License Agreement.
